

Barrett City Council Meeting Minutes
Monday, November 12, 2018
5:00 p.m.
Barrett City Office

Present: Mayor-Les Alvstad; Council-Todd Lang, Jason Wendt, Jodi Moss, Earl Janshen; Clerk/Treasurer-Marita Rhude; Maintenance-Gerald Puchalski. Guests: Michelle Jenson.

Mayor Alvstad called the meeting to order at 5:00 p.m.

Lang made a motion to approve the agenda as presented, seconded by Wendt.

Moss made a motion to approve the minutes of the regular October 9, 2018 meeting, seconded by Janshen. MCU

Lang made a motion to enter into a Law Enforcement Agreement with Grant County for 2019 for \$36,692.79, 2020 for \$37,793.57 and 2021 for \$38,927.37, seconded by Moss. Motion carried. Wendt abstained.

Janshen made a motion to hereby vacate the alleyway running between Lots 13, 14, 15 and 18, 19 and 20 in Block Eight (8) and also that portion of the platted alleyway bordering Lot 18 and ending at Rich Avenue, seconded by Lang. Roll Call Vote: Alvstad-yes, Janshen-yes, Lang-yes, Moss-yes, Wendt-yes. MCU
A Public Hearing was scheduled for Monday, December 10th at 4:30 p.m.

Barrett Lake Resort garbage billing error was discussed. Kent Marshall, City Attorney felt that we should go back 6 years as that is the length of time you can go back on a contract. The amount owed for 6 years was \$4,643.04. The error was first made in 2008, the amount owed from that date is \$7,343.04. Jeff Severance from Barrett Lake Resort wants the whole amount refunded as he doesn't feel garbage service is a contract. Moss made a motion to refund Barrett Lake Resort \$7,343.04, seconded by Janshen. MCU

Alvstad moved to resolve to certify result of the Tuesday, November 6, 2018 General Election as Council members Jason Clow for a two-year term and Michelle Jenson and Jodi Moss for four-year terms and Mayor Todd Lang for a two-year term, seconded by Lang. Roll Call Vote: Lang-yes, Janshen-yes, Wendt-yes, Moss-yes, Alvstad-yes.

Moss made a motion to accept a donation from the Barrett Fire Relief Association for the Fire Department in the amount of \$1,000 and a donation for the West Area Education Foundation for the Fire Department in the amount of \$264, seconded by Janshen. MCU

Alvstad made a motion to pay bills in the amount of \$58,096.53, seconded by Lang. MCU

Wendt made a motion to adjourn at 5:27 p.m., seconded by Janshen. MCU
